**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Drugs - 3rd Degree - Possess - Methamphet/Amphetamine in School/Park/Pub Housing Zone**

Minnesota Statute: 152.023.2(a)(6)

Maximum Sentence: 20 years or \$250,000, or both

Offense Level: Felony

Offense Date (on or about): 01/09/2018

Control #(ICR#): 18000123

Charge Description: On or about January 9, 2018, in the County of Rice, Minnesota, Taylor Peter Bossmann did unlawfully possess methamphetamine while in a school zone.

**COUNT II**

**Charge: Dangerous Weapons-Possess on School Property**

Minnesota Statute: 609.66.1d(a)

Maximum Sentence: up to 5 years prison, \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 01/09/2018

Control #(ICR#): 18000123

Charge Description: On or about January 9, 2018, in the County of Rice, Minnesota, Taylor Peter Bossmann did while knowingly on school property possess, store, or keep a dangerous weapon.

**COUNT III**

**Charge: Dangerous Weapons - Possess, store or keep replica firearm or BB gun knowingly on school property**

Minnesota Statute: 609.66.1d(c)

Maximum Sentence: up to 90 days jail, \$1,000 fine, or both

Offense Level: Misdemeanor

Offense Date (on or about): 01/09/2018

Control #(ICR#): 18000123

Charge Description: On or about January 9, 2018, in the County of Rice, Minnesota, Taylor Peter Bossmann did while knowingly on school property possess, store, or keep a replica firearm or BB gun.

## STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Complainant and/or Signing Officer designated below, declares under penalty of perjury, that he/she has reviewed police reports relating to the above-named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, believes the following to be true and correct.

On or about January 9, 2018 at approximately 8:00am, Faribault Police Department received a call from the Faribault High School. The Assistant Principal called to report a male possibly sleeping in a white SUV in the staff parking lot near the high school tennis courts.

Officers responded and found a white SUV with a male in the driver's seat. The SUV was running. The male appeared to be breathing but his eyes were closed. The officer approached from the passenger side. The officer saw a meth pipe sitting on the passenger seat of the vehicle. The officer identified the male as Taylor Peter Bossmann, DOB: 12/21/1984 (hereinafter the defendant). Other officers arrived on scene. One of the officers starting to open the driver's door and immediately saw a gun near the defendant. The officer quickly reached in to grab the gun before the defendant could wake up. The defendant was then removed from the vehicle and detained in a squad car.

The SUV was searched. In the back of the vehicle, officers found a large, fixed blade, Bowie style knife. Also in the vehicle, officers found miscellaneous coins, tools, cut copper piping, and various electronic devices. Found in the defendant's wallet were six counterfeit \$20 bills.

The gun was later found to be a BB gun with the look of being a real firearm.

A large, fixed blade, bowie knife is designed as a weapon and capable of causing death or great bodily harm.

The SUV was parked on school property.

The meth pipe did field test positive for methamphetamine.

The defendant was later taken to District One Hospital to get checked out. The defendant kept falling off the intake bench at the jail. The defendant would lay motionless on the holding cell floor while staff changed

him into jail clothing.

**PLEASE TAKE NOTICE:** Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court.
