The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Felony 5th Degree Controlled Substance- Possess Schedule 1,2,3,4

Minnesota Statute: 152.025.2(1), with reference to: 609.11.5a, 609.11.5a

Maximum Sentence: 3 to 5 years prison, \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 02/03/2018

Control #(ICR#): 18000057

Charge Description: On or about February 3, 2018, in Rice County, Minnesota, Souvanh Ly did unlawfully possess one or more mixtures containing a schedule II controlled substance, to wit: methamphetamine weighing more than .25 grams and while possessing a firearm.

COUNT II

Charge: Traffic-Drivers License-Driving After Revocation

Minnesota Statute: 171.24.2

Maximum Sentence: up to 90 days jail, \$1,000 fine, or both

Offense Level: Misdemeanor

Offense Date (on or about): 02/03/2018

Control #(ICR#): 18000057

Charge Description: On or about February 3, 2018, in the County of Rice, Minnesota, Souvanh Ger Ly did unlawfully drive a motor vehicle while his drivers license, or privilege to drive, was revoked.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:	

Complainant and/or Signing Officer designated below, declares under penalty of perjury, that he/she has reviewed police reports relating to the above-named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, believes the following to be true and correct.

On or about February 3, 2018, an off duty officer observed, in the City of Lonsdale, a Red in color van with MN plate 142-XVX parked on the west bound side of the road without lights on, and a male driver passed out with a firearm uncased and laying alongside of him. An officer from the Lonsdale Police Department responded along with a deputy from the Rice County Sheriff's Office.

When the officer arrived he noticed the van had a light coating of snow over it and the engine was not running. The officer approached from the passenger side of the van and immediately noticed blankets were blocking all windows on the driver side of the van. As officers approached the passenger side, one officer shined his flashlight into the van. At this time, the suspect woke up and immediately reached for his rifle that was sitting next to him. Officers immediately started to yell commands to the male. The male complied and put his hands on the roof of the vehicle. An officer then opened the passenger side sliding door and removed the rifle from the male's possession. The rifle was found to have a small drum style magazine, and was loaded with 11 rounds of .22 long rifle ammunition.

The male appeared to be sweating profusely, was very jumpy, and agitated. The male was holding a large green in color blanket over his lap. Officers asked if there were any other weapons in the vehicle. The male stated there was a knife. The officers had the male keep his hands in the air and not to reach for anything. The officer advised the male that he was going to remove the blanket and check for any other weapons. The male stated okay. As soon as the officer removed the blanket, the officer noticed the male was not wearing any pants or underwear. The officer then noticed a transparent pink in color glass pipe, multiple butane torch canisters and lighters, and a mirror with a white powdery substance on it.

The officer identified the male as Souvanh Ger Ly, DOB: 10/15/1964 (hereinafter the defendant). The defendant's driver's license came back as revoked. The officer asked the defendant to step out of the vehicle. The officer conducted a pat down of the defendant. The officer asked the defendant how much meth was in the vehicle, and the defendant stated he smoked everything that was in the van, after he got to where he was parked.

When asked what he was doing with the rifle out of the case and parked on the side of the road without any lights on, the defendant stated he was hunting squirrels.

The officer then searched the van. The officer found a socket in the driver side front door handle that had a green leafy substance inside of it with a burned residue on the end. The officer found a spoon with burned residue laying on the floor between the passenger and driver seats. The officer also found a yellow and blue canister of butane with a torch, an aluminum foil pipe with a green leafy substance with a strong odor of burned marijuana, and a green and purple plastic container with a white powdery residue.

The defendant gave a post *Miranda* statement. The defendant admitted that he just smokes methamphetamine. The defendant admitted the drugs were for personal use and not to sell. The defendant again stated he was hunting squirrels.

The officer returned to the vehicle and conducted a full search of the vehicle. The officer found a baggie with a brown leafy substance in a small storage compartment on the ceiling. The officer found a small baggie with a clear crystal rock substance in another storage compartment. The substance weighed 1.7 grams and tested positive for methamphetamine.

PLEASE TAKE NOTICE: Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court.
