**COMPLAINT**

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Assault-4th Deg-Motivated by Bias**

Minnesota Statute: 609.2231.4

Maximum Sentence: 1 year and/or \$3,000 fine

Offense Level: Gross Misdemeanor

Offense Date (on or about): 07/17/2018

Control #(ICR#): 18001034

Charge Description: On or about July 17, 2018, in the County of Rice, Minnesota, Alvin Clifford Rahman did assault another because of the victims or another's actual or perceived race, color, religion, sex, sexual orientation, disability as defined in section 363A.03, age or national origin.

**COUNT II**

**Charge: Assault in the fifth degree; Gross misdemeanor-Within three years of previous conviction.**

Minnesota Statute: 609.224.2(b)

Maximum Sentence: 1 year and/or \$3,000 fine

Offense Level: Gross Misdemeanor

Offense Date (on or about): 07/17/2018

Control #(ICR#): 18001034

Charge Description: On or about July 17, 2018, in the County of Rice, Minnesota, Alvin Clifford Rahman did assault another within three years of a previous qualified domestic violence-related offense conviction or adjudication of delinquency.

## STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Complainant and/or Signing Officer designated below, declares under penalty of perjury, that he/she has reviewed police reports relating to the above-named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, believes the following to be true and correct.

On July 17, 2018, officers were dispatched to 201 Greenvale Place, Northfield, Rice County, Minnesota, on reports of an assault. Upon arrival, Officer Jandro observed a black male and black female sitting at a picnic table. The male, identified as G.N.R.A., stated that he was assaulted by Alvin Clifford Rahman (DOB: 07/30/1953), a resident of his apartment complex. G.N.R.A. further explained that he and his wife were watching their one-year-old granddaughter and decided to take her outside to play.

A short time later, Rahman approached and referred to G.N.R.A.'s granddaughter as a monkey. G.N.R.A. took offense to Rahman's statement and the two began to argue. The fight became physical when Rahman grabbed G.N.R.A. by the throat and called G.N.R.A. a "Nigger." G.N.R.A. was grasping for breath while Rahman's hands were wrapped around his neck. Officer Jandro observed redness on G.N.R.A.'s neck which consistent was consistent with being choked. Several people who observed the assault were interviewed on scene. All of the witness statements corroborate G.N.R.A.'s statement to law enforcement. Rahman submitted to a preliminary breath test that revealed his alcohol concentration at .08.

Rahman has a previous qualified domestic-related conviction from October 28, 2015, in Court File No. 66-CR-15-1842. This conviction is being used to enhance the current charges.

**PLEASE TAKE NOTICE:** Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court.
