The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Fugitive from Justice from Other State

Minnesota Statute: 629.13

Maximum Sentence: Rendition to the demanding State

Offense Level: Felony

Offense Date (on or about): 07/11/2018

Control #(ICR#): 18000783

Charge Description: On or about July 10, 2018, within the County of Rice, the defendant, Tanner Fox Savo, is a fugitive from justice in that he is present in Rice County, Minnesota and having been charged with the commission of a crime in any other state and having fled from justice, or having been convicted of a crime in another state and having escaped from confinement, broken the terms of bail, probation, or parole, and the State of Alaska has issued a warrant for the defendants arrest and demanded the defendants return.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Complainant and/or Signing Officer designated below, declares under penalty of perjury, that he/she has reviewed police reports relating to the above-named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, believes the following to be true and correct.

The Defendant, Tanner Fox Savo, (DOB 11/24/1998), has an active Arrest Warrant out of the Third Judicial District at Dillingham, the State of Alaska. The defendant was indicted by a Grand Jury in the Third Judicial District at Dillingham, the State of Alaska, on July 5, 2018 for three Class C Felonies. Specifically, Sexual Abuse of a Minor (Alaska Statute 11.41.434(a)(1)), Sexual Abuse of a Minor (2) (Alaska Statute 11.41.436(a)(2)), and Incest (11.41.450(a)(2)). A subsequent Arrest Warrant was issued on July 5, 2018 for the arrest of defendant.

The Arrest Warrant has been confirmed as active.

The State of Alaska has confirmed that it will extradite defendant from Minnesota to Alaska.

PLEASE TAKE NOTICE: Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court.
