The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**Charge: Drugs - 2nd Degree - Sale Sch 1 or 2 narcotic, LSD, MDA, or MDMA in school/park/public housing zone**

## STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Complainant and/or Signing Officer designated below, declares under penalty of perjury, that he/she has reviewed police reports relating to the above-named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, believes the following to be true and correct.

On or about January 29, 2019, agents from the Cannon River Drug and Violent Offender Task Force spoke to a Confidential Reliable Source (CRS). The CRS stated Jeremy Jacob Hagen offered to sell 1 gram of heroin for \$200.00. Hagen arranged the deal to take place in the City of Faribault.

Agents met with the CRS. Agents provided the CRS with \$200.00 of pre-recorded government buy money. The CRS arrived at the arranged deal location. Hagen arrived and got into the vehicle with the CRS. Hagen gives the CRS the suspected heroin. The CRS gives \$180.00 of the pre-recorded government buy money to Hagen. Hagen exits the vehicle and leaves the location. The CRS leaves the location and meets with agents. The CRS immediately hands the suspected heroin to agents.

The sale arranged by Hagen took place in a Park Zone.

The suspected heroin tested positive for heroin and weighed 1.63 grams with packaging.

**PLEASE TAKE NOTICE:** Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court.
