CITY OF NORTHFIELD, MINNESOTA CITY COUNCIL RESOLUTION #2003-058

A JOINT RESOLUTION OF THE CITY OF NORTHFIELD AND THE TOWNSHIP OF NORTHFIELD ALLOWING THE CITY OF NORTHFIELD TO UNDERTAKE AN ENVIRONMENTAL ASSESSMENT WORKSHEET (EAW) FOR AN UNINCORPORATED AREA OF LAND WITHIN NORTHFIELD TOWNSHIP WHICH IS SCHEDULED FOR ANNEXATION IN 2003

- WHEREAS, the City of Northfield and the Township of Northfield desire to accommodate growth in the most orderly fashion; and
- WHEREAS, the City of Northfield and the Township of Northfield did adopt a joint resolution for orderly annexation on September 18, 1978 and October 10, 1978, respectively; and
- WHEREAS, the City of Northfield has approved a Conceptual Development Plan for the annexation of 78.7 acres submitted by Arcon Development, Inc (the "Developer") and Vernon Koester (the "Property Owner"), which is within the orderly annexation area and is expected to be annexed in March 2003; and
- WHEREAS, the City of Northfield and the Township of Northfield desire to allow the environmental assessment process to begin prior to annexation of the property to the City of Northfield, which will provide for timely review and development of the property; and
- WHEREAS, the timely development of this property will also benefit the City of Northfield by providing for the construction of the extension of Maple Street through the proposed Arcon development in 2003;
- WHEREAS, the Parties hereto desire to enter into the terms of this Joint Resolution;

NOW THEREFORE BE IT RESOLVED by the Township of Northfield (sometimes hereinafter referred to as "the Township") and the City of Northfield (sometimes hereinafter referred to as "the City") as follows:

1. The Township agrees to allow the City of Northfield to be the Responsible Government Unit (RGU) to undertake an environmental assessment through the completion of an Environmental Assessment Worksheet (EAW) of the property proposed for annexation by Arcon Development, Inc (the "Developer") and Vernon Koester (the "Property Owner"), which is legally described as follows:

THE NORTH ONE HALF OF THE SOUTHWEST QUARTER OF SECTION 7, TOWNSHIP 111, RANGE 19, RICE COUNTY, MINNESOTA.

- 2. The City shall follow the EAW process proscribed by the Minnesota Environmental Quality Board (Minnesota Rules Chapter 4410 4410.7900)
- 3. The City agrees to provide the Township with the following:
 - a. A copy of the completed EAW for each Town Board Supervisor.
 - b. Notice of the public hearing held by the Northfield Planning Commission to take comments on the EAW.
 - c. A copy of the final staff report and resolution regarding the City of Northfield's findings on the EAW.
- 4. The EAW process to be undertak en by the City of Northfield as RGU shall be accomplished at no cost to Northfield Township.
