RE: "Supplemental Agenda Background Memo" for June 9, 2020 No. 1.

Summary Report:

The following is an update on agenda items as supplemental background agenda information made available for Tuesday, June 9, 2020.

<u>Item 3 – Res. 2020-055 Consider alternative options for the Memorial Pool for the 2020 Summer Season due to COVID-19.</u>

The Governor's recent change in the guidelines regarding pools allows for pools to open at 50% capacity beginning June 10th. Staff is supportive of opening the pool July 1.

Capacity

The current capacity of the pool is 545. Staff measured the square footage of the actual pool areas and determined that 95 swimmers could be in the water and still be able to maintain the appropriate social distancing. 95 swimmers is well under the 50% occupancy capacity of the pools, but the social distance spacing ability in water is a more appropriate measure of the capacity.

Options

The new guidelines would likely fit with option 1C, the July 1st opening of the pool, from the original set of options put before the Council.

Operations

There would be 3 public sessions daily with sanitizing procedures between each session. The CDC has seen no evidence of the virus being transmitted via properly treated pool water. Staff would use an EPA registered disinfectant to sanitize the restrooms, high touch areas and limited seating options that would be available.

Financial considerations

Staff made assumptions of actual daily attendance. Based on those assumptions and the calculated capacity of the pools, staff recommends a budget amendment of an additional \$30,000 above the adopted general fund reserve support amount to support operations at the pool.

Future considerations

Should the Council choose to open the pool on July 1st, staff will continue to monitor the guidelines regarding capacity. Staff will adapt to the changes as they happen and make adjustments to the total number of swimmers that would be allowed per session which may also impact current revenue projections.

<u>Item No. 4 - Consideration of downtown public right of way changes including streets and parking to accommodate user changes related to COVID-19 community mitigation measures.</u>

Please see attached updated presentation materials. Many of the slides are the same but some revisions have been included.

<u>Item No.5. Consider Resolution of Support for police and criminal justice legislative reforms.</u>
City Administrator Martig and Mayor Pownell are recommending to remove this agenda item for this evening.

Staff has been monitoring pending legislation form the State of Minnesota but no specific bills have been identified. There will be significant thought put into what federal, state and local policies may be appropriate. Staff is committed to transparency and accountability in policieng and there will be future review and discussion on this topic. The public's questions, comments and feedback are always welcomed.

Tonight's Goals

• City Council decide if the pool will be open or closed for the 2020 season.

• Staff will run through alternative options available for Council



Special considerations due to COVID-19

- Current Governor Executive Order Through June 1 Prohibits Pools From Operating.
- Operational considerations if Governor Executive Orders for Pools Changes After June 1 but would require mitigation requirements:
 - Break day into two hour admission sessions with a limited number of patrons being allowed in during each session.
 - Sanitize facility between sessions
 - Require all patrons to bring their own chairs or blankets.
 - Mark out spots within the facility that comply with social distancing recommendations
 - Add signage to encourage best hygiene practices and assumption of risks



Special considerations due to COVID-19

• Operational considerations if Governor Executive Orders for Pools Changes After June 1 but would require mitigation requirements:

Sanitizing considerations

- Limited touch points at the pool
- Physical barrier has already been constructed
- Changing room will be sanitized between each two hour session
- Remove deck chairs to reduce touch points and sanitizing points
- All sources indicate that with a pool with proper chlorine level will kill the virus in the water



Social Considerations

- Provide community with recreation opportunity
- Provide a sense of normalcy
- Provide as safe of an recreation outlet as possible
- Continue the high level of service to the community
- Be aware of what surrounding communities are doing



- Alternative Option 1A Close the Pool for 2020 Season.
 - Full time staff would continue with repairs and catching up on deferred maintenance on the pool as included in the 2020 adopted budget
 - Cost savings estimated at \$22,342 would benefit the 2020 budget including the COVID-19 financial impacts.



- Alternative Option1b: Open Pool Mid-June
 - Season pass sales have already been postponed.
 - The modified admissions process, including limiting the number or patrons, would also bring the revenue numbers down.
 - A possible scenario based on an 80 day operating schedule and including 10 weather related closures:
 - Assuming 50% of the previous season pass holders will purchase daily admissions
 - 30 patrons per session X 3 sessions per day + Pass holder sales = \$60,000 season revenue total
 - Budget amendment of \$55,000 to operate the pool due to revenue shortfalls



- Alternative Option 1C Open Pool July 1.
 - The seasonal staffing and utilities line items would be able to be reduced by 30% each due to the pool not operating in the month of June.
 - Revenue projections based on a 50 day operating schedule including 7 weather related closures
 - Assuming 50% of the previous season pass holders will purchase daily admission
 - 30 admissions per session X 3 sessions per day + pass holder sales = \$48,300 season revenue
 - Budget amendment of \$30,000 to operate the pool due to revenue shortfalls




- Alternative option 1D Open the pool for swim clubs for organized youth sports and programs
 - As of June 1st pools are allowed to open for youth sports and youth programs per Executive Order 20-63
 - Temporary Staff line item reduced from \$100,000 to \$20,000 due to elimination of lifeguards. Keeping only a pool manager and staff to sanitize pool area
 - Current revenues from swim clubs are average around \$8,000 per year
 - Assuming an increase in rental revenue through addition of additional swim club rentals from local and non local clubs of \$7,000 for a total of \$15,000
 - The budget amendment resolution would require an additional \$19,000 of reserve fund support


Revenue Risks & Comparisons (May 5, 2020)

- At this time, the current biggest risks to the City of Northfield are likely to be 2021 impacts including potential delinquent property taxes, sensitivity to local property tax increases and State cuts in LGA
 - General Fund Property Tax levy at \$7.2M is 51% of the General Fund Revenue
 - LGA budgeted at \$3.2M is 23% of the General Fund



Financial Update

- At this time, more optimistic on economy a month later with clarity on re-openings and unemployment statistics as of June
- Future may change particularly in Fall and Winter season



2021 Considerations

- Potential General Fund Revenue Impact
 - <u>Could be</u> a \$900K reduction in Revenue (current worst case scenario estimating)
 - Property tax and LGA, based on 2008 impact
 - Likely spread over 2020 and 2021
 - TOO EARLY to assume this for action steps
 - Best case estimate LGA stays at same or very similar levels to 2021 and little impact to property tax delinquencies



Action this Evening

- Resolution has three options
- Alternative 1A Close the Pool staff recommended
- Alternative 1B Open Pool Mid-June budget amendment of \$55,000 from the General Reserve Fund to Operations Budget
- Alternative 1 C Open Pool July 1 budget amendment of \$30,000 from the General Reserve Fund to Operations Budget.

My name is Megan Ann Holleran. I live in Northfield with my husband and three school aged children. My oldest is a member of the Bullsharks Swim Team. I am writing to show my support for opening the Old Memorial Swimming Pool.

As a swim official with United States Swimming I have been closely following research and guidelines for swim facility re-opening. Outdoor pools, such as ours, are low risk for COVID-19 transmission. Clear and consistent policies can be put in place to mitigate risks. Lap swimming presents less risk then recreational open swim, although they can both be done safely with appropriate policies in place.

I understand revenue will likely be down due to COVID-19 policies, but opening the pool is still the correct decision. It serves the Northfield community and it is an especially important service given the cancelation of so many other summer programs. We need to look at the pool as an essential community service like the library. The main goal is public health safety

- Enabling people to observe the requested 6' distancing
- Safety in terms of not being in a street with cars and trucks in it (unless with something like barrels or bollards)
 - On water street bridge, people have been stepping off the high curb and onto the street
- Safety for all kinds of users, including older adults and accessibility concerns




