- WHEREAS, the wastewater and water operations have planned for additional growth within the municipal boundaries and in identified growth areas and are appropriate to supplement other legal fees for this review.

- 1. The City Council authorizes the Finance Director to transfer \$50,000.00 from the Wastewater Fund #602 to the General Fund #101 for additional Legal Fees.
- 2. The City Council authorizes the Finance Director to transfer \$50,000.00 from the Water Fund #601 to the General Fund #101 for additional Legal Fees.
- 3. The City Council authorizes the Finance Director to increase Legal Fees in the 2019 General Fund budget by \$100,000.00.
