#### DUNDAS CITY COUNCIL REGULAR MEETING MINUTES Monday, December 9, 2024 7:00 p.m. City Hall

CALL TO ORDER Mayor Switzer called the meeting to order at 7:00 PM.

- i. Staff Presentation
  - Public Comment

Mayor Switzer opened the public hearing at 7:01 PM and indicated that the discussion tonight would be brief since the City Council has been working on this budget for the last several months and had held four work sessions. The preliminary levy was adopted in September as required and there were no changes to the proposed budget and levy since September. Finance Director Jessi Sturtz presented the proposed 2025 General Fund Budget and 2025 Final Property Tax Levy. Ms. Sturtz walked through a power point presentation that took the charts and graphs from her memorandum that was included in the agenda packet. The proposed levy is a 5.3% increase, which keeps the tax rate level with 2024. If the assessed values were to remain flat in 2025, taxpayers would see a slight reduction in the City's portion of their tax bills.

Scott Code, 215 Hagerty St asked why the Economic Development Authority was made up of City Council members and then made several remarks about his property taxes increasing over the years.

Doug Lange, 1118 Bluff Street spoke and inquired about the increase in his property values, he commented that there was no increase in public benefit with this budget.

Mayor Switzer closed the public hearing at 7:23 PM

The Mayor and City Council members reiterated that this budget has been discussed several times at public meetings since May of 2024. They encouraged both the people attending the meeting and others to engage in the process earlier in the year and to reach out to staff with specific questions on projects and line items in the budget.

These were previously discussed with the City Council when they reviewed the Proposed 2025 Enterprise Fund Budgets and are included in the 2025 budget.

#### CITY OF DUNDAS COUNTY OF RICE STATE OF MINNESOTA

#### **RESOLUTION NUMBER 2025-01**

#### A Resolution Designating Depositories and Establishing Procedures for Depositing and Investing Funds

**WHEREAS,** Minnesota Statutes §118A.02 requires the governing body of each government entity to designate one or more financial institutions as depositories of funds; and

**WHEREAS,** Minnesota Statutes §118A.01 Sub. 3 defines financial institution as "...savings association, commercial bank, trust company, credit union..."; and

**WHEREAS,** the financial institutions to be designated meet the requirements of the State of Minnesota and the City of Dundas;

**NOW, THEREFORE BE IT RESOLVED,** that Frandsen Bank and Trust of Dundas, Minnesota is hereby designated as a depository for the funds of the City of Dundas; the City Administrator/Clerk is authorized to deposit City funds therein in accordance with Minnesota Statues §118A.01 to 118A.06; and

**BE IT FURTHER RESOLVED,** that, in accordance with Minnesota Statutes §118A, Sub.1, Sec. b, the City Administrator/Clerk be authorized to designate additional depositories; and

**BE IT FURTHER RESOLVED,** for deposits beyond insurance the depositories will furnish collateral in the manner and to the extent permitted by law. All such collateral must be approved by the Dundas City Council and accompanied by a written assignment providing that, upon default, the financial institution shall release to the Dundas City Council on demand, free of exchange or any other charges, the collateral pledged; and

**BE IT FURTHER RESOLVED**, that all collateral must be placed in safekeeping in a restricted account at either a Federal Reserve Bank or in an account at a trust department of a commercial bank or other financial institution that is not owned or controlled by the financial institution that has furnished the collateral. The selection must be approved by the Dundas City Council. In case of default upon the part of the depository, the Dundas City Council shall have full power and authority to sell such collateral or, as much as may be necessary, to realize the full amount due the City over such federal guarantee.

SUBJECT: Consider Approving 2025 Salary Adjustments

DATE: For the City Council Meeting of January 13, 2025

PURPOSE/ACTION REQUESTED

Consider approving salary adjustments for 2025.

#### SUMMARY

The Compensation Plan that the City Council approved in 2022 contemplated two items with respect to annual salary adjustments for city staff;

- 1) All positions were placed in a pay structure with grades and steps to allow movements from one step to the next based upon length of service; and
- 2) An annual COLA adjustment, the wages of the pay plan are adjusted upwards each year using a cost-of-living factor or percentage.

Employees who are at the top of the respective range receive only the COLA.

Attached is the 2025 Compensation Plan based on the 3% COLA adjustment approved as part of the 2025 budget process.

Dear Staff and Council,

Chapel Brewing is hosting a 5k and 10k fun run on Saturday, June 21<sup>st</sup> as part of the Minnesota Brewery Running Series (MBRS). We've hosted this event with much success annually since we opened, making this the eighth time. This family-friendly run brings over 100 people to Dundas that day, mostly from the Twin Cities area. Many of them like what they experience and return to Dundas, patronizing Chapel and other local businesses.

Typically, these runs are during the day starting at 11am, but for something new & unique, the MBRS wants to do a run in the evening coinciding with sunset. And they think of all the breweries they work with, Chapel/Dundas is the perfect place to try it out. Because this run is unique, we think MBRS participants will be excited about attending, and Chapel's excited the Running Series chose Dundas as the location.

For the participants to run/walk in daylight and arrive at the brewery prior to sunset, the run would start around 8pm. Runners and walkers finish at various times, but most are done within an hour, with the last ones getting back around 9pm (sun sets at 9:05). Given that, we would like to remain open past our usual 10pm closing time for this event. Our plan is to do last call at 10pm and have everybody off the premises by 11pm. This extended closing time gives the run participants and their friends & family the opportunity to enjoy their post-run time in Dundas without being rushed. To facilitate that, we are respectfully asking for a variance to stay open until 11pm on Saturday, June 21, 2025.

In addition to the variance, we are requesting an extension of our service area to include our parking lot as in year's past, allowing attendees to circulate there with a beer. The run starts and stops in the parking lot, and the MBRS sets up a tent in the lot along with tents for the non-profits they support (giving back to the community is part of their business model). We would only allow consumption of beer in the parking lot until 10pm, moving any remaining people to the deck and beer garden at that time.

As in previous years, we will do the following:

- Keep people within the designated area of the parking lot by utilizing a single access point, roping off the designated area and positioning employees and volunteers to monitor the perimeter
- Serve beer consumed in the parking lot in plastic glasses
- Obtain Insurance coverage which includes the parking lot area
- Promote parking in the municipal lot

Thank you for your consideration of the variance and extension of service area, and for your assistance in making this fun-run a successful event that benefits both Chapel and Dundas.

#### City of Dundas Public Works Staff Meeting / *City Engineer Update 1/8/25* January 9, 2025 Agenda

The City Administrator, Public Works Director, and City Engineer meet at least monthly to plan and review projects and tasks, and to discuss public works matters of all types. The agenda used for the most recent Public Works staff meeting forms the basis for the updates that are provided to the City Council. Following is the most recent Public Works staff meeting agenda with notes added.

- 1. 2024 Street Lighting
  - Staff removed the area of sidewalk required for the Contractor to complete the work on the lights. The remaining concrete sidewalk will be removed next spring.
- 2. Comprehensive Transportation Planning
  - Staff prepared a preliminary road design and estimate of project costs for street improvements for a portion of 115th Street between CSAH 20 and CSAH 22. Staff have begun internal discussions on the future alignment between Highland Parkway and Cannon City Boulevard.
  - 12-9-24 Corridor Study was finalized and is consistent with the City's Comprehensive Transportation Plan.
- 3. CSAH 1/TH 3 Pedestrian Crossing
  - The scope of work includes installing a trail along CSAH 1, connecting to the existing sidewalks on Schilling Drive, Cannon Road, and North Stafford Road. A trail connection would also be made to the existing trail along TH 3. Pedestrian crossing improvements would be made to the intersection of TH 3 and CSAH 1. Ditch grading and storm sewer improvements would be made to accommodate the trails.
  - Funding in the amount of \$370,000 has been allocated to the project in the State's 2023 Capital Budget under Grants to Political Subdivisions.
  - Staff have revised the scope of work to include the concrete walk along Schilling Drive and from the Dundas Dome to the City limits on Cannon Road.
  - 4-22-24 Council approved staff to begin work on the project.
  - The agreement has been executed with the State to secure funding for the design of the project. WSB has started design and preparation of construction plans.
  - The proposed schedule is to have complete plans and specifications, including MnDOT review, completed in March 2025. Construction would be completed in 2025.
  - Staff will be reviewing the 60% construction plans the week of 1-20-25.
- 4. Northfield Wastewater Treatment
  - Northfield received written approval from the PCA for the permit amendment. The City of Northfield will approve future sanitary sewer extension permits, and the surcharge will be discontinued while the City's flows remain within the revised limits.

- 5. Public Works Tasks
  - The storm water code and fees are under review, including sump pump connection requirements.
- 6. 2025 Pond Maintenance
  - The work in the pond south of County Road 1, within Schilling Park, will be completed in 2025 to allow time for the dog park to be moved and the existing fence to be removed. The project will include the pond slope grading in the Menard Pond south of Hester.
  - Staff received notice from Menards that the easement for the pond south of Hester Street will be signed and sent over to City staff. Staff plans to perform the pond maintenance in the Menards pond in 2026 as part of a separate project.
  - The Contractor has cleared the trees from the pond areas and started excavations in the pond area. The pond excavations are anticipated to take two-weeks to complete.
- 7. Public Works Cold Storage
  - The preliminary site plan and building details were presented to Council on 2-27-23.
  - Estimated project costs and available funding were reviewed by the Public Works Committee on 10-4-23.
  - 10-18-23 Staff met to review and discuss the project scope to work towards finalizing building details.
- 8. Sanitary Sewer and Water Comprehensive Plan
  - Staff are reviewing the draft comprehensive plans.
- 9. 2025 Schilling Drive Sanitary Sewer Repairs
  - 10-9-23 Council authorized staff to proceed with project.
  - The scope of work includes a sanitary sewer connection between two manholes at the intersection of Hester Street and Schilling Drive. The project will redirect sanitary sewer flows from the north and east to bypass the sanitary sewer line on Schilling Drive that has settlement issues. WSB has started design and production of construction plans.
- 10. Mill Towns State Trail
  - The DNR is targeting 2025 to construct the trail from the pedestrian bridge in Mill Park to 118<sup>th</sup> Street, terminating at the railroad tracks.
  - Staff has reviewed the preliminary construction plans and provided comments to the DNR.
- 11. Dundas Boulevard Watermain Improvements
  - The scope of work includes installing a new watermain down Dundas Boulevard from Millstone Lane to Hester Street.
  - 10-14-24 Council authorized staff to begin work on plans and specifications.
  - WSB has started design and production of construction plans.
  - The draft construction plans have been completed and reviewed by staff. Staff are working to finalize the quote package for the project.
